**C. ATTENDED CAREER FAIRS,
MADE “PROCUREMENT AS
A PROFESSION”
PRESENTATION, OR
CREATED OUTREACH TO A
SPECIFIC AUDIENCE**

Members of CAGP employed with the City of Raleigh, Wake County, Wake County Public Schools, Town of Cary and Town of Garner (NC) participated in the 22nd Annual Small Business Expo – hosted by the City of Raleigh (NC) – where the local government, municipalities and school district partnered to inform minority and women-owned businesses of upcoming opportunities to propose or bid for construction projects, professional services and other services, or goods and apparatus.

The City of Raleigh along with Carolina Small Business Development fund, Greater Raleigh Chamber of Commerce, Women’s Business Centers of North Carolina and Wake Tech Community College sponsored “Raleigh Small Business Connect: A meet and greet with vendors and Triangle local governments designed to educate potential small business owners and current small business owners how to connect with local governments” (photos attached). The local government and other organizations set up tables to distribute information and for vendors to collaborate.



CAGP members from the Town of Cary participated in the State (NC) Minority Women Business Enterprise Conference. Members of the NC MWBE organization met for a two-day

conference to learn and share information and participate in a small vendor meet and greet.



CAGP President, Shaun Mizell, presented a special session at the 2020 Conference titled “Procurement of the Future”.



As a perpetual effort, CAGP has implemented outreach to a specific audience at the opening of our Annual Spring Conference – “First Timer’s Orientation”. At this session, the First Timers are informed of conference logistics, expectations for attendees and how to become more involved with CAGP.

E. ORGANIZED STUDY GROUP FOR CERTIFICATION EXAM PREPARATION

CAGP coordinates an annual Certified Local Government Purchasing Officer (CLGPO) Exam Review session approximately two weeks prior to exam administration. This exam review is hosted by an agency located in the central portion of NC in an effort to be accessible for any and all members preparing to sit for the exam. The review session study group is invaluable in maintaining a high passage rate.
