KPPA 34TH ANNUAL FORUM & VENDOR EXPO

Nearly 300 attendees learned how to "Build Better Procurement" during KPPA's Annual Forum and Vendor Expo held at Louisville's Galt House Hotel in November. Sessions covering a broad range of procurement issues and professional development were offered through a range of locally and nationally known speakers.

The conference kicked off with "Rapper" Linda (Lawson) demonstrating how to stay right side up when everything else is upside down. From there, attendees dived into sessions dealing with such topics as how to handle procurement protests, IT solution tips, and Microsoft products to name a few. Monday evening provided an opportunity for attendees to network at the social event where members were treated to a mock casino night, music and snacks. Members were able to use their "winnings" to trade in for tickets for door prizes.

Thursday's agenda started with Kevin McCarthy telling his personal story of how he spent 33 months in a federal prison for a crime he unknowingly committed. His real-life story provided an eye-opening reality check for members to be aware of their actions. Afterwards, members broke out into concurrent sessions before walking to the Kentucky International Convention Center for lunch and the vendor expo where 139 vendors were on hand to meet and demonstrate their products to members.

Friday's session closed out with Doug Graham, a KPPA entertaining favorite, who inspired members how to build a better anything before the award luncheon. KPPA committees were recognized during the luncheon along with KPPA's community partner, Blessings in a Backpack, who provides food on the weekends for elementary school children who might otherwise go hungry. On Friday, the donations were delivered to the Blessings in a Backpack representative at the awards luncheon.

In addition, KPPA past presidents at the awards luncheon gathered on stage and were recognized with special pins to show KPPA's appreciation for their service. David Hecker Retired from CHFS

Many were shocked and saddened in August to hear the news that longtime state employee and KPPA staple David Hecker was retiring.

I have heard tales of such folklores as Big Foot, Santa Claus, Lochness Monster, and now David Hecker retiring. For those of us who have known "Hecker" for very long we have heard him tell tales of retiring, but no one ever thought the day would come. He worked for the Commonwealth of Kentucky, Cabinet for Health and Family Services (CHFS) for so long he was a legend and became known as Mr. CHFS because he was a wealth of knowledge.

David retired from state government after working 27 years, all of which were at CHFS. When David retired, he was serving as the wireless coordinator and Procard site administrator for CHFS and was responsible for the Cabinet's security guard contracts. His technical skills from his day job carried over to his work on the KPPA Board.

For 7 years, David served as a Board member and helped wherever he was needed but primarily served as the main point of contact for all things IT related. You would see him at KPPA functions setting up projectors and sound, helping speakers with their equipment needs and floating from room to room taking pictures. David spent hours overseeing KPPA's equipment needs, in addition to editing photos for the organization. Until the Board started transitioning those tasks, we never truly realized just how much he did behind the scenes for KPPA. For years, he took care of things that you do not think about until they don't work, such as the KPPA website and mobile app. David generously provided KPPA the use of his own equipment, which saved KPPA hundreds of dollars each year in rental fees. He was a tireless leader and team player for KPPA and yet still displayed a servant's heart for his community.

He has been extremely active for many years with the WeWannaPlay, Inc. organization, which raises money to help defray the cost of playing sports for local students who could not otherwise have the financial means to participate in athletics. David also finds time to do sports broadcasting for several sports organizations and his experience announcing games was always evident when he made announcements at KPPA. You may still get to hear his "broadcast voice" at future KPPA events as David has promised to return if he is available.

I'm sure we'll find him outdoors on most days now pursuing two of his favorite activities, canoeing and biking. Although the Commonwealth and the KPPA Board lost a truly remarkable person when David retired, we wish him the best in his retirement pursuits.







AGENCY SPOTLIGHT

KYTC Division of Equipment

The Kentucky Transportation Cabinet, Division of Equipment does so much more than purchase and maintain equipment. The Division consists of a Central Office administrative group, a consolidated Transportation Warehouse, a Central Office Repair Branch (C-1 Garage), a Central Office Administrative and Sales Section (Surplus/Salvage Section) where used equipment can be exchanged by customers as needed, a Central Office Equipment Procurement Branch and 12 district repair garages.

The Central Office Transportation Warehouse is responsible for equipment repair parts, traffic signal and lighting needs as well as employee safety. The C-1 Garage includes both a machine and welding shop and repairs equipment statewide. They also manage all leased vehicles for the Finance and Administration Cabinet's Division of Fleet Management which includes permanently assigned vehicles and mileage reports, and administering leased vehicle assignments, turn-ins, fuel cards, maintenance requests, repair and temporary vehicle needs.

In addition to maintaining equipment and managing the statewide Operations Management System software for equipment fleet inventory and maintenance tracking, the Central Office operates the statewide 2-way Radio Communications System for equipment operator and employee communication. Communications Section provides mobile radios and communications supporting 48 repeaters across the state. There are 35 radio repeaters providing communication from Frankfort Transportation Operations Center via COT's KEWS microwave system and covers 12 Highway District Offices and Facilities.

The 12 district repair garages are located around the state providing each highway district with local repairs and emergency item stockroom facilities. Each garage is staffed with mechanical, technical and administrative personnel providing local customer service for repairs.

The Division of Equipment provides equipment and services necessary for public safety that includes snow and ice removal, highway surface repairs, traffic control system repair and right-of-way mowing. The division also assists other cabinets with equipment transport and repair.



Chapter Swap

In 2016, Kentucky began working with other NIGP chapters to setup a "Chapter Swap" where each chapter would send a representative to the other chapter's annual forum as a way to learn best practices from each other. Since that time, KPPA has been to New Mexico and South Carolina and in 2019 decided to work with the Rocky Mountain Governmental Purchasing Association (RMGPA) in Colorado.

When I found out in August that I would be traveling to Colorado as KPPA's Chapter Swap representative, I was so excited for the opportunity and then immediately thought, "Wait a minute! Travel to Denver in December?! Are they nuts?!" Although there were piles of snow throughout Fort Collins when I arrived, the roads were completely clear; as my RMGPA hosts had assured me they would be prior to my arrival. I would not have to worry about being stranded in Colorado.



My trip to RMGPA's Winter Conference and Vendor Trade Show was so enlightening. I found it fascinating to learn about the variables that RMGPA has to consider when planning their activities due to their membership and landscape, literally, the state's terrain. RMGPA is comprised of members from both Colorado and Wyoming. Due to the landscape and where members are situated, location is a key factor when RMGPA plans events. Currently they hold four conferences/trainings each year but are considering changing this in 2020 as a result of visiting KPPA's annual forum in November. After seeing how we run a "mini NIGP forum" in November, RMGPA was impressed with our three-day event but I am just as amazed that they would go through the effort of setting up four events each year due to the logistics and planning needed for each.

RMGPA's Winter Conference and Vendor Trade Show is roughly a day and a half. It is setup similar to KPPA's forum but on a smaller scale. A few key differences I noticed pertained to member involvement. Included within RMGPA's conference agenda was a business meeting and a separate swearing in ceremony for their newly elected officers. All members are invited to the activities where they are provided copies of committee reports and included in the voting at the business meeting. RMGPA's awards ceremony is held in the evening as an awards gala with dinner and music provided by a DJ. This is an opportunity for members to dress up in their semi-formal wear in a beautiful holiday decorated setting or you are just as welcome in jeans and casual attire.

My time spent in Colorado was a blast! I had so many questions and everyone was so friendly and helpful, no matter how many questions I asked. My wonderful host Traci Gorman (RMGPA's President) took such great care of me and even picked me up and dropped me off at the airport so I would not have to drive the hour commute to and from Fort Collins. What I saw of the snowcapped Rocky Mountains on our commute and the sights when we were out at dinner was beautiful. I was even shocked to have someone approach me at the conference who had previously worked in Kentucky's Office of Procurement Services – Garrett Duff. He and his wife had moved to Colorado several years ago and he is now working in purchasing for Colorado State University.

I crammed a lot of learning in my two days at conference, but we also had fun. One of the highlights of RMGPA's conference is their ugly Christmas sweater contest. The winner is awarded RMGPA's ugly sweater trophy (an old fishing trophy of a previous member) and the winner has to add something to the trophy and return it for the next year's conference. I was informed about this contest before my trip so I came prepared. Let me just say, I was a little embarrassed walking into breakfast the morning of the contest wearing a horrendous looking sweater but the laughter and cheers made it all worthwhile when I stepped through the door. RMGPA's ugly sweater contest trophy now sits proudly on my desk at the Capitol Annex! I just have to figure out what to add to it before I return it to them next year!

This was a wonderful opportunity provided by KPPA! Even if you do not have a chance to participate in a Chapter Swap, I encourage you to mingle and meet others at NIGP (and KPPA) events. Even now, that I am back in Kentucky, one of RMGPA's members has reached out to me about our scholarship processes and I have contact information from them if we need assistance planning our reverse trade show. It is amazing what you can learn from other chapters and how helpful others can be if you only ask.





Tips & Tricks

Email Rules

Wouldn't it be wonderful to get an eye catching alert on your computer screen when you are waiting on time sensitive information? Follow the steps below to set-up a basic rule for your email:



- 1. Click on File across the top tabs.
- 2. Click on Manage Rules & Alerts.
- 3. Click on New Rule.
- Under the section titled "start from a blank rule": Select "Apply rule on messages I receive". Click Next.
- 5. Select the condition(s) you wish to apply (Step 1 in the Rules Wizard box) and enter the criteria (Step 2 in the Rules Wizard box) and click Next.

Example #1: Waiting on information from Finance and Administration Cabinet or an internal agency regarding RFI Demonstrations. Choose "specific words" in step one. Click the blue link for "specific words" in step two—a new dialogue box will open. Type the phrase "RFI Demo" in the phrase and click Add.

Result: Any email message with the phrase "RFI Demo" will create a pop-up box.

Example #2: Emailed a vendor for a time sensitive price quote and you want to be notified immediately when you get a response email. Choose "people or public group" in step one. Click the blue link for "people or public group" in step two—a new dialogue box will open. Enter the email address for the person and click OK.

Result: Any email message received from the selected contact(s) will create a pop-up box.

- 6. Select "display a specific message in the New Item Alert Window" and in step 2 name the alert window. This names the pop-up box so you know what type of alert message you are getting. This is very handy if you have multiple alerts set. For example #1 above, you might name it RFI Demo or in example #2 Price Quote Alert.
- 7. Click Finish.

You can establish multiple rules; however, be careful that your parameters do not overlap. If they overlap, your alerts will not work properly.
