WHEREAS, procurement professionals make important contributions to assure the responsible use of taxpayer dollars by providing efficient service while maintaining the highest ethical standards; and

WHEREAS, local, state, and federal purchasing professionals are responsible for managing and monitoring billions of dollars of goods and services every year, which directly influence the national and international economy; and

WHEREAS, purchasing and procurement operations range from departments of one to several thousand employees; and

WHEREAS, the Carolinas Association of Governmental Purchasing, the National Institute of Governmental Purchasing, the North Carolina Division of Purchase and Contract, and other associations around the globe are sponsoring activities and other special events to further educate and inform the general public regarding the role of purchasing;

NOW, THEREFORE, J. ROY COOPER, Governor of the State of North Carolina, do hereby proclaim March, 2020, as "PROCUREMENT MONTH" in North Carolina, and commend its observance to all citizens.
