Ready to Earn Your NIGP-CPP?

Quick Tips

- 1. Read the online NIGP-CPP Certification Handbook before you apply. It's your essential source of NIGP-CPP information and contains everything you need to know to evaluate the program and complete the certification requirements. (As part of the application, you will attest to Candidate Declarations, including the statement that you have read the Certification Handbook).
- 2. Apply Online (we recommend you apply 30 days prior to the first day of the test window you desire.
- 3. Be prepared to make a \$150 payment for the **application.** (Application fee is non-refundable)
- 4. Once your application is approved, you will receive instructions on how to register and pay exam fees for a specific testing window.
 - You have a choice of the months of February, May, August and November and the testing windows open five months in advance for registration.
 - If you are a current CPPO or CPPB certificant (or lapsed within one year), you will only take a bridge (Module B) exam. All other candidates take a two-part modular exam (Module A and Module B) and you have flexibility to register for each module individually.
 - Exam fees are \$100 per exam module

5. Application Period: Active for 2 years after approval
